



Bold City Soccer Academy 2025–2026 Competitive Player Agreement

I/We are applying to register the player named above as a member of the **Bold City Soccer Academy Competitive Division** for the 2025–2026 season.

I/We understand and agree to the following:

- This commitment is for the full term: **June 1, 2025 – May 31, 2026**.
- Player selection and team placement are at the sole discretion of the Director of Coaching and Competitive Coaching Team.
- We agree to follow the rules, policies, and expectations set by Bold City Soccer Academy, the Florida Youth Soccer Association (FYSA), the Elite Development Program (EDP), and US Youth Soccer (USYS)—including all parent and player guidelines and responsibilities.
- Continued participation in the program is contingent upon adherence to all rules, agreements, and policies by both the player and their family.

Registration Fee

- The **registration fee** for the 2025–2026 Competitive Season is **\$50**, due upon acceptance of team placement.

Team Fees

To ensure consistency across the club, Bold City Soccer Academy will implement **monthly team fees of \$185**, beginning **June 1, 2025**.

Team fees will be collected by the Academy administration through electronic billing.

Players who do not remain current on payments may be held out of **practices, games, and tournaments** until payments are received.

Team Fees Include:

- A minimum of 3 training sessions per week
- League fees
- Referee fees

Note: *Team fees do not include tournament fees.*



Refund Policy

Registration, team, and tournament fees are **non-refundable** and **non-transferable**, even in cases of player absence, withdrawal, or release from the team or club.

The only exceptions considered for **prorated refunds** are:

- Medically documented injuries preventing play for more than half the season.
- Job relocation of a parent/legal guardian outside the area (proof required).

Financial Assistance

Families requiring financial assistance should contact **admin@boldcitysoccer.com** to discuss available options.

Decisions will be made by the Bold City Board of Directors or Scholarship Committee and communicated via email.

Note:

- Acceptance of a scholarship may require additional volunteer hours.
- Registration and uniform fees are not covered by scholarship awards and remain the responsibility of the family.
- Any scholarship funds granted apply only to team fees.

Uniform Requirement

- All players must purchase the required uniform kit.
- Uniforms must be ordered by May 31st if the player did not participate in the previous season.
